

## Re-cycling Information for End Users

The following information is applicable for eInstruction Corporation products (eInstruction, Interwrite, and GTCO Calcomp brands).

- End user Requirement is that they must have Waste of Electrical and Electronic Equipment (WEEE) disposed and treated properly in regard to the Ordinance (2005:209) on Producer Responsibility for Electrical and Electronic Products.
- eInstruction Corporation has arranged and covered the cost for the treatment which provides for de-pollution, disassembly, reprocessing, recovery or preparation for disposal and any other operation carried out for the recovery or the disposal of WEEE in regards to the Ordinance (2005:209) on Producer Responsibility for Electrical and Electronic Products.
- The end-user will deliver eInstruction Corporation's waste of electrical and electronic equipment to the following collection points managed by Kuusakoski Oy for de-pollution, disassembly, reprocessing, recovery or preparation for disposal (all points are located in Finland):
